

RELEASE AND DISCHARGE FROM LIABILITY

I, _____, of legal age, _____, property owner and resident of _____, Puerto Rico, freely and voluntarily declare under oath:

1. I am the owner of a cargo of live animal(s) consisting of _#_____ _____ , # _____).
2. I will use the services of Marine Express, Inc. to transport the above mentioned cargo of live animal(s) from San Juan, Puerto Rico, to Santo Domingo, Dominican Republic, pursuant to Bill of Lading number _____, voyage number _____, vessel M/V KYDON.

It has been explained to me and I am aware that ocean transportation, by its nature, presents risks for the health and life of animals and that Marine Express, Inc. will not be legally or contractually liable for damages that the animals to be transported may suffer during transit, including but not limited to death or other physical injuries. Pursuant to the United States Carriage of Goods by Sea Act, Marine Express, Inc. has agreed to carry the previously mentioned live animal(s) by sea solely at the shipper's risk of accident, disease or mortality and without warranty of undertaking whatsoever.
4. Being aware of all the above, I hereby confirm my decision to proceed with the shipment of the mentioned cargo of live animal(s) from San Juan, Puerto Rico, to Santo Domingo, Dominican Republic. I further confirm that such decision is free, intelligent, informed and voluntary and that I, as shipper, authorize the carriage of said live animal(s) at my sole risk of accident, disease or mortality during any stage of transportation between the port of origin and the port of destination.

Marine Express, Inc., its affiliated companies and their respective shareholders, officers, representatives and/or employees are hereby expressly released, discharged and held harmless from any claim for death, injury or any other possible damage to the mentioned cargo of live animal(s) that may directly or indirectly result from its transportation process between the port of origin and the port of destination.
6. In addition to all the foregoing, I undertake each and all responsibility with respect

to permits, veterinary, sanitary or other certifications, or any other documents, that may be required for exportation of the previously mentioned cargo of live animal(s) from the United States of America and its importation into the Dominican Republic Marine Express, Inc., its affiliated companies and their respective shareholders, officers, representatives and/or employees, are expressly released, discharged and held harmless with regards to the obtainment of any permits, certifications, approvals or other documents that may be required for exportation/importation of the cargo at issue herein from the United States of America to the Dominican Republic.
